- (a) A written clearance confirming the exemption of the ship being granted by the Regional Manager (Gold Coast) and any further conditions as determined and specified by the Regional Manager (Gold Coast).
- (b) This exemption only applies to the waters of the Southport pilotage area.
- (c) This exemption is effective immediately and operates until 30 June 2005.
