Publication and reporting of data sourced from the Cancer Alliance Queensland

1. You will review all Cancer Alliance Queensland data intended for publication, and seek advice if required, to ascertain whether any individual/s or hospitals/health services are potentially identifiable. If there is a risk that individuals or hospitals/health services can be identified then you will identify and seek the appropriate approvals for the release of potentially identifiable information.

2. All electronic or hard copies of any Cancer Alliance Queensland data will cite the source and the date accessed as follows:

Queensland Government.[data source or name of publication]: Cancer Alliance Queensland. Queensland Health, Brisbane, YYYY

3. If, after approval under the relevant sections of the Acts, you publish abstracts that refer to any part of the Cancer Alliance Queensland data you must:

I. Cite Cancer Alliance Queensland as follows:

‘Data used in the preparation of this article was obtained from the Queensland Oncology Repository-Discovery data and QOOL. QOR-Discovery data and QOOL are managed by the Queensland Cancer Control Analysis Team (QCCAT) on behalf of the Queensland Cancer Control Safety and Quality Partnership.’

II. You do not need to include reference to the Cancer Alliance Queensland, The Partnership, QCCAT, QOR-Discovery data or QOOL in the authorship line of the abstract.

III. You must upload the published abstracts onto the Cancer Alliance Queensland website either after being accepted or after being presented. Contact the Cancer Alliance Queensland to upload publications CancerDataQld@health.qld.gov.au

4. If, after approval under the relevant sections of the Acts, you publish manuscripts which refer to or use any part of the Cancer Alliance Queensland data, you must:

On the authorship line of the manuscript, after the named authors, include the phrase ‘and the Cancer Alliance Queensland’ with the asterisk referring to the following statement * Data used in the preparation of this article was obtained from QOR-Discovery or QOOL managed by the Queensland Cancer Control Analysis Team under the auspices of the Queensland Cancer Control Safety and Quality Partnership, a gazetted quality assurance committee under Part 6, Division 1 of the *Hospital and Health Boards Act 2011* (Gazetted 10 December 2004). The Cancer Alliance Queensland contributed data but did not participate in the analysis or writing of this manuscript.



5. If you believe that you do not have space to include the full required acknowledgements pursuant to clauses 3 and 4, you must obtain written consent from the Cancer Alliance Queensland to publish QOR-Discovery or QOOL data. You can request consent by sending a notice to the Senior Director of Cancer Alliance Queensland specifying the proposed shortened acknowledgment.
